

# International report enhancements

Freshly developed profiles in BusinessIQSM and GDN API

## What is happening?

Beginning on Sept. 21, 2018, Same Day Reports will now be available in the 62 countries. Additionally, you will start receiving developed profile reports in two new digital formats with much quicker turnaround times. These two new reports will be delivered in the same digital format as our current online Small and Extended Reports, providing current, detailed and consistent reports on businesses virtually anywhere in the world.

Finally, developed profiles will now be archived, providing opportunities for users to instantly access available international reports globally at a discount. Where archived reports are available\* the date they were created will be clearly displayed, allowing users to decide whether the report is current enough to meet their needs, or if they would prefer, they can order a freshly developed profile on the company. Archived reports are offered at a discount, providing additional value. And if after viewing the archived report, you order a freshly developed report on the same company within 24 hours, the archived report is free. Please contact your account manager for additional details regarding archived developed profiles.

These developed profile enhancements will be available through both BusinessIQ<sup>SM</sup> and Global Data Network (GDN) API.

#### What new report options will be available?

Through either BusinessIQ or the GDN API, users will be able to conduct a business search using the enhanced service virtually anywhere in the world. When a business has been located, you can order either an Extended Report or a Small Report.

- > Extended Report options:
  - Download instantly (if an archived report is available for the inquired-upon business)
  - Request Extended Report normal delivery (arrives in three to seven days)
  - Request Extended Report express delivery (arrives in one to three days)
- Small Report options:
  - Download instantly (if an archived report is available for the inquired upon business)
  - Request Small Report normal delivery (arrives in one to three days)
  - Request Small Report same day express delivery (arrives in 24 hours and available in 62 countries)

# What do I need to do to access the enhanced reports?

BusinessIQ users who currently can order international reports will automatically be able to access the enhanced reports. Users of the GDN API will need to code to new endpoints to access/request freshly developed profiles using our modernized, state of the art API Hub. Contact your account manager for additional details on the new endpoints.

## What will happen to reports I ordered on or before Sept. 21?

We will be officially making the switch to our new developed profile service after business hours (Pacific Standard Time) on Sept. 21. This means that all orders received prior to the cutover to our new developed profile service will continue to use our current system. If your order was received before the cutover, you will receive a PDF report once it is available, and the existing report service SLAs will still apply.
